1. All above Officials are promoted at their present place of posting presently and their transfer/posting order will be issued separately in due course as per administrative feasibility and in accordance with

- orders/directions issued by Headquarters' Office. Consequent upon their joining to the promoted post they will have all India transfer liability
2. Promotion of the officials will take effect from the date on which they assume charge of Social Security Officer/Manager Gr. II/Office Superintendent.
  3. Promotees who are already officiating as Social Security Officer on 28.04.2026 i.e. the date of the meeting of the Departmental Promotion Committee, will be deemed to have been promoted on regular basis on 28.04.2026 itself, provided that they accept this promotion as per para 17.11 of DOPT OM dated 10.04.1989.
  4. Promotees, who have been promoted on ad-hoc basis as Social Security Officer on or after 28.04.2026 and are officiating without interruption, will be deemed to have been promoted on regular basis on the dates when they had assumed charge as Social Security Officer on ad-hoc basis, provided they accept this promotion, provided they do not suffer from any disqualification specified in Para 11.1 of the instruction issued by the DOPT in OM no. 22011/4/91 Estt. (D) dated 14.09.92.
  5. All promotees will be on probation for a period of one year from the date of their regular promotion as per provisions of Recruitment Regulations, 2007 for the post of SSO/ Manager Gr.II/ Supdt.
  6. Upon promotion, pay will be fixed in level-7 (Rs. 44,900-1,42,400/-) as per the provisions of FR 22 (1)(a)(1). Promotees shall exercise their option for fixation of pay under FR 22(1)(a)(1) within one month from the date of promotion as per the saving clause under the FR22(1)(a)(1).
  7. The joining of the above officials to the post of SSO/Manager Gr.-II/Superintendent shall be communicated by the official concerned, latest by 12.06.2026 (in enclosed format), to their controlling authority.
  8. The official at Sr. No.24 who has already been promoted to the post of SSO/Manager Gr.-II/Supdt. through LDCE has the option to accept the promotion from either of the mode of promotion and the option once exercised will be final.
  9. The official at Sr. No.24 who has already been promoted through LDCE and assumed the charge of the post on promotion, his date of promotion by effecting this order will be as per the extant rule.
  10. The officials who decline the offer of promotion will not be considered for regular promotion for a period of one year from the date of refusal of first promotion or till a next vacancy arises whichever is later (as per para 17.12 of DOPT OM dated 10.04.1989) and will also be passed over resulting in loss of seniority, as per rule, and the other officers promoted on regular basis prior to the dates of their next promotion to the cadre of Social Security will become senior to them.
  11. The seniority of the aforesaid officials will be fixed as per the extant rules and as per the panel recommended by DPC.
  12. The proceedings of the DPC held on 28.04.2026 and the promotion order

are subject to further orders which may be passed by Hon'ble Supreme Court in light of DOPT O.M. No. 36012/11/2016-Estt( Res.I) dated 15.06.2018. The above proceedings and promotion order are also subject to court/CAT case, if any, in the matter of Seniority in the cadre of Assistant etc.

13. All the other terms and conditions of Office Order no. 102 and 103 dated 05.06.2026, which is not in contrary to the above will remain the same.
